



# United States Bowling Congress Joyce Deitch Unity Award

## Purpose

The USBC Joyce Deitch Unity Award is named for the seventh president of the Women's International Bowling Congress. It recognizes organizations and individuals who have made important contributions to bowling by being motivators, visionaries, leaders and innovators.

## Eligibility

Please note the following:

- Nominees' contributions should extend beyond the local or state levels.
- The award does not focus on years of service.
- It can be given posthumously.
- It can be given to a woman or a man.
- Current USBC board members, members emeritae and hall-of-fame members are ineligible.
- Candidates nominated in previous years, and not selected, may be re-nominated.

## Nomination Procedure

Anyone may nominate a candidate. To nominate someone, you must:

- Complete this official nomination form.
- Include or attach any additional supporting documentation.

Note: Candidate may complete form themselves with no nominator.

## Submission

Your application must be made using this official form. Feel free to include any additional information that will support your nomination. All application materials and supporting documents must be sent no later than December 1. See Section E at the end of this form for information on submission deadlines and procedures.

- Applications sent via U.S. Mail must have all signatures and titles; must include all reference letters and supporting materials; and must be postmarked no later than December 1.
- Applications sent via fax must have all signatures and titles and must be faxed no later than midnight your time zone, December 1. Reference letters and any other supporting materials must be sent via U.S. Mail and postmarked no later than December 1.
- Applications sent via e-mail must include all names and titles, as legal e-signatures, and must be sent as an attachment to an e-mail no later than midnight your time zone, December 1. Reference letters and any other supporting materials must be sent via U.S. Mail, and postmarked no later than December 1.
