TOURNAMENT RULES

PARTICIPANTS WITH RESERVED ENTRIES MUST REPORT 1/2 HOUR BEFORE SQUAD TIME WITH CURRENT USBC CARD. ALL OTHERS REPORT AT LEAST 1 HOUR PRIOR TO START OF SQUAD.

1. All entrants must be sanctioned in the 2011-2012 season with the Southern Nevada USBC Association. Unsanctioned bowlers can purchase a USBC membership card at tournament site per Rule 300c.
2. Bowlers may bowl as many times as they want with, but may cash ***only one time*** with each partner.
3. Tournament shall be handicap Mixed Doubles (1 man and 1 woman) and a separate Optional Scratch Mixed Doubles Event. Bowlers will each bowl 3 games on one pair of lanes.
4. HANDICAP will be (90%) of difference between each bowlers average and 225.
5. Prize Ratio for Handicap will be at least 1 in 5. Prize Ratio for Scratch will be at least 1 in 6. Prize fee will be returned 100%. Winners for both scratch and handicap will be awarded individual plaques, to be presented at the SNUSBCA Awards Banquet.
6. ***AVERAGE USAGE as follows:***
 - a. Highest 2010 - 2011 Winter Book Average with at least 21 games.
 - b. Highest 2010 - 2011 Summer average with at least 21 games.
 - c. Highest current average with at least 21 games as of January 7, 2012.
 - d. All others must use 225 (SCRATCH).
7. No Sport or Tough Shot averages will be allowed.
8. ***Rule 319a will apply.*** (Ten pin rule & average verification – Rules 319a-2 & 319a-3). Bowlers are responsible for verifying their own average whether submitted by the bowler or others. All bowlers with an average in another Association from the previous season shall furnish verification from their previous Association Manager in writing before closing date of this tournament. Failure to follow this rule may result in disqualification from the tournament.
9. ***Rules 319c and 319e*** (average adjustment re-ratings appeals) ***will apply*** to all USBC members. In accordance with Rule 319c, the average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded. For Rule 319e, a bowler shall adjust his/her entering average if, during the 12-month period immediately preceding the time and date of bowling, the bowler's accumulated average for all, but not less than 21 tournament games, exceeds the average to be used for entry by 15 or more pins. In that case, the accumulated average must be used for handicapping or classification purposes.
10. Any rules not covered shall be governed by USBC Sanctioned Tournament Rules. Decisions of the Tournament Director shall be final unless an appeal is made in accordance with Rule 329.
11. Entries will close 1 hour prior to final squad on Sunday, January 29, 2012.
12. No PBA Exempt players are allowed to participate.
13. Lanes shall be conditioned in between the second and third squads.
14. All entries must be paid prior to bowling.
