## TOURNAMENT HOST & LOCATION Grand Sierra Greater Reno Sparks

#### **Tournament Rules**

**<u>Rules:</u>** USBC rules shall govern this tournament. The board of directors of Nevada State USBC Association shall decide on all questions not covered by the tournament rules. The board shall have the power to hear and act on all protests concerning this tournament.

Membership: All participants must be members of the USBC, a local Nevada USBC association and the Nevada State USBC Association, holding a current membership card

Entering Averages: Rule 319a WILL APPLY. (Ten pin rule & average verification – Rules 319a-2 & 319a-3).Rules 319c and 319e WILL APPLY to all USBC members. Rule 202a WILL APPLY. Entering averages shall be used in the following order:

- a) Highest 2014-15 USBC book, provided it is the highest 21 or more games bowled in one league, including substitute averages. 2015 summer averages for 21 games or more are considered book averages if the bowler has no regular season average. (Combined averages are not permitted). Entrants without a 2014-15 USBC book average will be eligible to bowl under the following provisions which apply in the order listed.
- b) Highest 21 games or more as of December 31, 2015.
- c) First 21 game average completed after December 31, 2015 prior to the date of first competition in the tournament.
- d) An entrant without an average as provided herein will be permitted to bowl in the tournament, however, entries which include such entrants will automatically be classified in Division 1 of the event and NO handicap will be given to the entrants without an established average. Teams or individuals entering the tournament under the provisions of (b), (c) or (d) of this rule will send their entry to the state association tournament manager, omitting the average(s) of the entrants exercising this privilege. As soon as an average has been established as outlined herein, this average, as verified by the local association manager, shall be sent to the state association tournament manager on the form provided.

**Entries:** Names must be the same as on USBC Membership Card. **No Nicknames.** Entries shall be mailed or delivered only to the Nevada State USBC Association, C/O Randy Parker PO BOX 35364, Las Vegas, NV. 89133-5364. Entries must be accompanied by full entry and fees in the form of check or money order payable to Nevada State USBC Association. **Any returned check will be subject to a \$25.00 return check fee. Any on site entries must be submitted a minimum of one hour before the squad. No refund of fees once the entry has been accepted and scheduled.** 

**Scheduling:** Entries will be scheduled according to requests, if possible, and in the order received. Traveling entrants (outside a 120 mile radius of the host association) will be given schedule preference when possible. Teams wishing to bowl together should send entries in the same envelope. **Participation:** Participants must live within a 75 mile radius of the Nevada State border and have completed 12 games in a Nevada State league.

Members may enter as many times as you wish in each event of the state tournaments. A member who is entered in either (or both) team events and/or doubles event and/or singles event, is also permitted to substitute in each of these events. In order to place more than once on the prize list for position standings, at least two players in the lineup must be different for team event and at least one player in the lineup must be different for doubles event. Only the highest score bowled in the singles event will qualify for prizes. A bowler's first appearance in team event and/or doubles event and/or singles event will event will qualify for prizes. A bowler's first appearance in team event and/or doubles event and/or singles event counts toward their all events total.

<u>All Events</u>: To be eligible for All Events awards in each division, the participant must complete three consecutive games in each event. The bowler's first appearance in any event will count towards All Events.

**Lineup:** The playing lineup shall be the same as submitted on the original entry form. Names must be the same as on USBC Membership Card. No Nicknames.

Scratch Singles: The entrant in the Optional Scratch Singles event securing the greatest total pins scratch for three games in the Singles event shall be the Scratch Singles Champion. The Scratch Singles event is optional, is open to all entrants who pay the optional fee and encompasses all divisions. **Awards:** Individual awards and championship emblems are given for first place in each division of each event. Sponsor awards are presented to sponsored teams only. Additional \$100 cash for highest nine-game scratch all events, emblems/pins for 200 scratch games, emblems for participation in 20 Nevada State Women's Championship tournaments, plaques for 25, 30, etc. tournaments and first time tournament bowler recognition. *Lookin' Sharp* pins will be awarded to those team entrants who are dressed alike. Criteria includes (1) Same color bottoms <u>and</u> (2) identical sponsor shirts <u>or</u> (3) same color, same style shirt or (4) same style shirts, different colors.

Schedule/Receipts: Schedule information, rules and receipts will be mailed to captains of traveling teams within 15 days after entry is received. Local teams will receive this information within 15 days after entries close.

<u>Closing Date:</u> Onsite registration one hour before the start of any squad. Late Entries: Late entries will be accepted as follows: On site entries must be submitted a minimum of one hour before the squad.

All entries are processed as they come in and Post office dates will be used to determine date of entry; postage machine dates will not be accepted as date stamp for entry. All entries are based upon availability in each squad.
