## TOURNAMENT RULES

1. This tournament is only open to 500 Club of Southern Nevada members in good standing. (MEMBERSHIP NEEDS TO BE PAID FOR THE YEAR 2024)
2. This tournament will be a doubles 10 pin tournament, where a first ball pin fall of 10 will count as a strike. This tournament will be bowled on a single pair of lanes; no moving.
3. Check in begins at 10:30 A.M. and closes at 11:15 A.M. Mystery double partner will be assigned at 11:30 A.M.
4. This will be a handicapped tournament; handicap based on $90 \%$ of 210.

Pay outs at least I in 6
5. Averages will be taken in this order, 1) Highest Winter book average 2022-23; 2) Highest Summer book average of 2022-23; 3) Highest Winter book average
2021-22; 4) Current league average of 21 or more games (attach current league sheets with entry form or you will not be permitted to bowl). If none of the above, bowler will enter with a $\mathbf{2 0 0}$ average
6. Fee for tournament is $\$ 30.00$ with $\$ 9.00$ going to lineage, $\$ 1.00$ club expense, and $\$ 20.00$ going to the prize fund. Due to Tournament being a Mystery Doubles there will be NO ON-SITE Registration
7. A side pot will be available on site for $\$ 6.00$ each for handicap and/or scratch ( $\$ 2.00$ goes toward each game). Payouts will be paid after tournament results are posted. ( 30 days)
8. Tardy bowlers will not be allowed to bowl, due to Mystery Doubles. Substitution will be allowed, but the original entrant either must notify the Tournament Director or the substitute must check in (1) hour before squad time. ALL substitutes must comply with previous stated eligibility requirements.
9. Tournament Director shall have the authority to handle all questions and have the final say on anything not covered in these rules.
10. Full entry fee must accompany entry form; Make checks and money orders payable to 500 Club of Southern Nevada. Need to be received no later than April 10, 2024.
11. Bowlers will only be able to receive a refund with a 24 hour notice.
